Fee: Stall holders must pay their Application Fee prior to 4 October 2012. Fees & application form returned to GoldRush, PO Box 248, GYMPIE QLD 4570.

Public Liability Insurance: Certificate of Currency must be returned with application form to secure booking.

Food Hygiene Certificate: Must be returned with application form to secure booking if serving food.

Cancellations: No refund will be paid after 4 October 2012

Allocated Area: The stallholder must only trade within the site allocated, and site locations will not be amended on the day. Sites will range from 3m-10m. All sites must be left in a clean condition on conclusion of the Event

Late applications: Applications will not be accepted after the closing date of 3 October 2012.

Site Set-up: Stallholder must set up their display/stall in a safe workmanlike manner, and comply with safety standards.

Risk Assessment: Each stallholder shall be responsible for managing all risks occurring from their activity.

Stallholders must abide by any direction given by the Gympie District Gold Rush Festival Committee which includes, market convenors, the Event Coordinator and Gympie Regional Council Officers in relation to risk management.
